Summer Camp Procedures and Policies

WEEKLY PAYMENTS:

- **Payments must be made 6:00 PM on the Wednesday PRIOR to the next week session. Payments will be accepted until the Friday prior to the next session by 10:00 AM for an additional fee of \$20. Payments made after this deadline will not be accepted. (NO EXCEPTIONS)**
- **Note:** A \$25.00 fine will be assessed for returned check and the \$20 late sign up fee will be applied.

You can make your weekly payments in the following ways:

Note: Payments may be made weekly or several weeks at a time.

1. Drop off payments in the payment box located in the preschool hallway across from room four between the hours of 6:00 AM and 6:00 PM, Monday – Friday. **NOTE:** This box is checked each morning at 10 AM, **if you make your payment after 10 AM on Friday your child will not be permitted to attend camp the following week. (NO EXCEPTIONS)**

3. Submit payment to office staff during office hours. (M-Th 9:00 - 4:00 PM F 9:00 - 3:30 PM)

If you require a receipt for your weekly payment let us know via a note and we will have the receipt at the pick-up gate by the end of each week.

THERE ARE NO REFUNDS OR PRORATIONS:

Partial sessions and/or weeks/days will not be prorated and are non-refundable. If you have already paid for an upcoming session and will not be attending you may move the weekly fee to the next scheduled week as long as the office has been notified by 10:00 AM the Friday before, no changes will be issued after this time. Note: No refunds will be given. You may add weeks as long as we are notified by 10:00 AM the Friday before and the camp/trips have space available at the time of your request.

LATE PICK UP FINES

If you are late picking your child up from their program you will be charged \$10.00 for the first 15 minutes and then \$1.00 per minute thereafter. Fees must be paid within one week of fine being charged. Campers will not be allowed to return to camp if late pick up fines are not paid in a timely manner. There are no exceptions to late pick up fines. The camp counselors do not have the authority to waive these fines.

COMPLETED REGISTRATION

Summer camp registration is complete upon the return of the completed packet and full payment of registration fees. No child will be accepted on campus if registration has not been completed. Your child's summer camp space will not be held unless registration has been completed.

DAILY ATTENDANCE AT SUMMER CAMP

Your child must be signed in and out each day. Failure to do so will result in the camp's inability to care for your child. You will be phoned immediately to either return to sign in your child or to pick them up. Campers are required to wear their camp t-shirts on all off campus field trips. **If your child shows up without their camp t-shirt or the necessary items required for that days field trips they will be denied entrance to camp, no exceptions.** See the camp field trip schedule list for the field trip instructions, and post in a prominent location in your home and/or work.

DROPPING OFF AND PICKING UP CAMPERS

Parents must park their car in an appropriate parking space, walk their camper to or from the gate/building, and sign their camper in or out. NO camper can be accepted or released without the proper sign in/out by the parent or authorized adult. Campers are not allowed to sign themselves in or out. Please do not park in the handicap parking unless you have the appropriate reason to do so.

Pick up area/time may change when we return from some field trips to accommodate the camper's comfort/health or a late trip return time. Redirection signs will be posted.

***Please Note:** Calvary Chapel Christian School does not have the legal authority to prohibit or restrict the natural parent(s) access to a camper's records or physical contact with the camper in relationship to a custody case unless a copy of the legal documents are on file in our office. The school can only carry out the instructions specified in the final custody papers, divorce decree, court order or restraining order with the proper legal paperwork.

If there are conditions which prohibit either natural parent from physical custody of the camper, it is the responsibility of the parent who has legal custody to provide the school with the PROPER PAPERS.

CAMPER RELEASE PROCEDURE

To further protect your child, the procedures below will be enforced:

- Campers will be released only to authorized adults (18 years or older) listed on the camper's "Emergency Information Sheet". The authorized adult may be requested to present valid picture identification before we will release a camper into their care. (The first time a person picks up a camper ID will be required, please bring your ID to the sign out area every day as the closing camp leaders may rotate hours and the counselor on duty may not recognize you and will ask for ID.)
- No camper will be released to any person whose name does not appear on the "Emergency Information Sheet" unless we have been notified in writing by the parents prior to camper pick up. **NO exceptions!**
- **If a camper is picked up late due to release issues, late pick up fees will apply.**

LUNCHES

Daily lunches are NOT provided for your child. Campers must bring a sack lunch each day. Keep in mind when packing lunches that the camp is unable to refrigerate or microwave/cook any food for campers. Some field trips will require sack lunches. The cost for field trip lunches, which must be purchased, has already been added into your weekly/daily fee. See camp field trip schedule list for the field trip instructions, post in a prominent location in your home.

SNACK SHOP

Snacks for children may be brought from home, or you may utilize our on campus snack shop. Items are priced from .25 cents to \$1.00 each. Snack cards can be purchased in the front office Monday-Friday in the amounts \$5.00, \$10.00, \$15.00 or \$20.00 dollars. Snack shop items will include a variety of healthy snacks such as fruit cups, string cheese, fruit bars, etc. for the morning break. During the afternoon break choices will range from healthy snacks to fun snacks such as cookies, ice cream, cracker jacks, etc.

SUMMER CAMP DRESS CODE

1. All clothing must be modest, neat, clean and in good taste.
2. Hair must be neat, clean and well-groomed.
3. Sandals must be worn with socks (sandals must have a back).
4. Slogan and picture shirts inconsistent with church philosophy are inappropriate.
5. It is recommended that girls wear shorts under dresses.
6. All shorts must be modest and the minimum length should reach the same distances as your finger tips when you arms are down to your side. NO short shorts will be allowed.
7. Pants and shorts must not sag; if they are loose the student will be required to wear a belt.

Camp T-shirts must be worn on all field trips (swim trip participant girls will need a one piece bathing suit or tankini with no mid-riffs visible. Boys should wear appropriately fitted swim trunks or shorts. Campers not wearing their camp T-shirts will not be allowed entrance into camp that day.

RESPONSIBILITY OF THE DAY CAMP

CCCS is not responsible for damage to personal property or lost articles. This must be considered when you decide which toys or items you allow your child to bring to camp. A child is permitted to bring games/gameboys, balls etc. on Fridays. It is necessary to excluded toy guns and knives or games were guns/knives/weapons of any kind are used to play the game or games with magic and spells. All games/items brought to school must get the camp director /asst. camp director approval before shared with other campers or played on church campus. Summer Adventure campers are not allowed to bring cell phones to camp. Solid Rock Campers *are* allowed to bring cell phones to camp. They will however lose this privilege if we find they are abusing it by doing or sharing inappropriate material or using it in an unacceptable/immoral way.

DISCIPLINE POLICY

Assertive discipline is exercised to aid staff and campers in creating a positive learning, social and fun filled environment. Positive and negative consequences are given according to camper's behavior and performances, in both the activity rooms, on the playground, and on off campus activities.

Three rules will be enforced at all times: Talk in Turn, Hands to Self and Be on Task. We will stress to the campers that in doing these three things we are showing God's love to one another. The camp leaders will use attention getting songs or clapping to get campers attention when needed. Campers will be taught a variety of camp songs/chants which will be used to keep our groups organized and focused on the tasks at hand.

CONDUCT REFERRALS

Conduct referrals will be used to inform parents of unacceptable behavior or continued breaking of camp rules. **Three conduct referrals will result in the removal of the camper from our program with no refunds.**

EXPULSION OR SUSPENSION FROM THE SUMMER CAMP PROGRAM

A camper will be suspended or expelled from the summer camp program or activities if the following behaviors are exhibited by the camper.

1. Willful disobedience
2. Defiance of authority
3. Deliberate physical or verbal harm to another camper or staff member (bullying of any kind will not be tolerated)
4. Profanity or vulgarity
5. Possession of tobacco or drugs on or off school premises
6. Stealing
7. Refusal to do assigned tasks
8. Refusal to obey camp rules
9. Defacing camp/church property
10. Numerous infractions of camp rules (or numerous conduct referrals for smaller infractions)

No refunds will be given if a camper is suspended, expelled or loses their activity privileges due to behavior issues.

POSITIVE CONSEQUENCES

Positive Consequences' will include but are not limited to the following:

Praiseworthy notes home

Gotcha Tickets (to be redeemed for prizes)

High fives

Special privileges (getting to go first, extra time of the activity when available etc)

More Free Time Activities

Weekly Surprises

NEGATIVE CONSEQUENCES

Negative consequences' will include but are not limited to the following:

Time – Out (head's down, removal from the activity)

Loss of privileges (workshops, field trips, activities)

Conduct referrals

Phone call home/Parent intervention

Suspension for a day, a week

Expulsion from camp program

EMERGENCY PROCEDURES

In order to be prepared for the possibility of an emergency such as fire or earthquake, the camp takes the following steps:

- Fire and Earthquake Drills
- All staff are trained in CPR and First Aid
- Emergency packs are located in each classroom and are carried by each staff member if off campus
- Extra supplies to care for the campers needs for 3 to 5 days are stored on campus in the event of a natural disaster.

CAMPUS SECURITY

For the safety of your child we are a closed campus. Anyone visiting the campus must stop at the office and sign in our visitor log and receive and wear a visitor's pass while on our campus. If you see someone without a visitor pass, inform the office or staff member immediately. All employee's at CCCS are easy to identify they will either be wearing an employee badge or a staff shirt/jacket. CCCS hallways and outside areas are also monitored by 24 hour surveillance cameras.

To help us keep our campus secure we ask that you only use the appropriate doors to enter and exit our premises and never open a locked door to anyone (even if you know them).

We will practice "lock down" drills to make sure the staff and campers know what is expected in an emergency situation.

MEDICATION DURING CAMP HOURS

If medication is needed during camp hours the following procedures must be followed:

- All medications require a signed release from the parent each time the camper is on that medication. (Not each day)
- Prescriptive medications require the camper's name be on the prescription
- Over the counter medications must not exceed the recommended age or dosages unless prescribed by a physician then the above procedure applies.
- All medication must be turned in to the office. (If dropping off before office hours then you may give to the opening camp leader with all the appropriate paperwork.) Campers are not allowed to carry their medications at any time.
- Aspirin-free pain reliever (i.e. Tylenol) may be administered to a camper if deemed necessary by the staff, if the verbal parental consent has been given and we have the parental written consent on file.

Note: Students on or need a fever reducer are not permitted on campus until they have been fever free and off medication for a minimum of 6 hours.

We desire our parents and students to hold these values and understand these doctrines for themselves. We realize with age and maturity these matters will become more understandable. Any teaching about these matters will be age appropriate and in line with curriculum. It is our hope that they are also reinforced at home, thus our entire reason for providing the ministry of this school is to provide education based upon these common beliefs.

Rejecting the essentials of these beliefs and doctrines may lead to dissent and lack of unity which exists everywhere outside of the faith. Our intent is to preserve unity based upon shared doctrinal and theological views, thus we request you carefully read, acknowledge and affirm, individually, each item below.
